BUSINESS**

The Board has discussed and recommended an increase in our Class prices. The reasoning for this recommendation is:

2024 Club Income = 310,275

2024 Club expenses = 273,820 (this is what it cost us to keep the club open for 2024)

2024 Profit as of August = 10,186

2025 Profit as of August = **-4,052** Our profit is down **-\$14,000** from this time last year.

Our expenses have increased \$17,000 since August 2024. This is mainly due to a huge increase from Com Ed and a decrease in class registration.

To cover the increase in expenses the Board has recommended the following price increase:

Obedience, Rally, Nosework, Tricks, Therapy Classes = \$130

Agility, Tracking Classes = \$150

This recommendation will be discussed and voted on at the November meeting
